On Friday contractors began work on the road and sewer replacement along Wright Avenue from 4th Street to Chippewa Ave. This project is expected to be completed by September, 11th 2020. I had the opportunity to speak with Steve Davidson of the Village of Shepherd regarding the project, Steve assured me that the contractors would not use the parish parking lot to stage from, or store equipment. That said there will be times that our neighbors along Wright Ave will not have access to their driveways, and I said it will be fine if they need to park in the North West Lot occasionally. Steve also assured me that during the project the old tree stumps along Wright Ave will be removed. I pray this project goes as smoothly as possible.
