Dear Friends in Christ.

It is hard to imagine that 6 years today, as I write this, I first arrived on the SVDP Parish Campus. Joyce Riley was secretary/bookkeeper at that time, Brent Moeggenborg was the Finance Council chair, and Jerry Degruise was the Pastoral Council chair. I remember that Jerry rode his motorcycle out that day to meet with me and put my mind at ease.

Although Bishop Cistone encouraged me to take the role of Pastoral Administrator, and appointed me to SVDP, I really didn't know what I was getting into. I remember, perhaps even that first week, celebrating a word service and meeting Elizabeth, Bev, Don, the Carey sisters and their husbands, and a number of the daily service folks. It wasn't until months later that I learned that the Carey ladies were all related.

My early assignment was made official on Friday, June 1st. That weekend, Fr. Fred and Joshua encouraged me to introduce myself to the parish before mass, the last thing I really wanted to do. The next weekend they did the same, and again the following. My habit of greeting everyone before it Liturgy is rooted in those first days here.

When Fr. Bill, Fr. Christian, and Sr Chris interviewed me for the pastoral administrator position, they asked what the first thing I would say to a new parish as my goal for them. I tried to back out of answering by saying I should learn about the community first. Fr Christian did not let me off the hook that easily. In the end, my answer was that I hope each of us is a little bit closer to God one year from now.

That answer has been in the back of my head for over six years now. We sometimes get bogged down in councils and committees, roofing and brickwork, and what day to schedule a picnic or graduation mass. But underlying everything, every day, every decision is made with my sincere hope that we all grow just a little bit closer to God.
